- Does the entity expect that it will continue to have the current level of net operating cash flows for the time being and, if not, why not?

Answer: No. Expenditures in the March 2020 quarter included expenditures related to the Definitive Feasibility Study ('DFS') for the HPA First Project. The DFS was completed during the quarter. Whilst a post DFS technical program is being undertaken expenditures will be well below that of the March 2020 quarter.

- Has the entity taken any steps, or does it propose to take any steps, to raise further cash to fund its operations and, if so, what are those steps and how likely does it believe that they will be successful?

Answer: Having released the DFS for the HPA First Project, the Company is now advancing the project permitting and approvals, as well as advancing discussions with potential HPA offtake partners. At the same time discussions with parties regarding financing of the HPA First Project will be held. As noted in the ASX announcement dated 17 March 2020 'HPA First Project DFS' the Board has now committed to a full project financing process and financial approval is anticipated to follow shortly after regulatory approval.

3. Does the entity expect to be able to continue its operations and to meet its business objectives and, if so, on what basis?

Answer: Yes. The DFS for the HPA First Project has validated the HPA First Project as a compelling business case, laying the foundation for the permitting, financing and construction of the project.
